Many clients and brokers are keen to ensure that the carbon footprints of their charters are counterbalanced. This is easy to do - team up with Yacht Carbon Offset! Carbon offsetting is a way to improve the environmental profile of a yacht charter by effectively counterbalancing greenhouse gas emissions from the charter activity.

1. We work with the charter broker and captain to identify the fuel consumption of the charter.

4. We issue a personalised certificate stating the tonnes of CO₂ offset, the associated fuel or charter activity, and the project selected.



2. We calculate the greenhouse gas emissions associated with the identified fuel and other charter activities (as appropriate).



3. We complete the offset by supporting a high-quality carbon reduction project, validated by one of four International Carbon Registries.



Our Carbon Offset Price

Example Charter Week (metres, m)	Fuel Consumption (litres)	Tonnes Emitted (tCO ₂ e)	Carbon Offset Cost (€)	
20-39m	5,000	14	€ 243	
40-49m	10,000	28	€ 422	
50-59m	15,000	42	€ 595	
60-69m	25,000	70	€ 942	
70+ m	50,000	139	€1,810	

For example, carbon offsetting a 7-day charter on a 50-metre yacht consuming **15,000 litres** of fuel would cost just **€595** (at Q1, 2023).

You will know that fuel consumption for a week's charter depends on the yacht's size, operational characteristics, and the charter itinerary. The charter offset can be based on either an actual or estimated fuel quantity, or a monetary offset value. Yacht Carbon Offset can help you estimate the charter's fuel consumption, if required.

The timing of the carbon offset transaction completion can be adapted to best suit the needs of the charter broker and the charter client.

The Order Process

We have two charter offset models. Either the Broker or the Charter Client can pay:

1. Your Choice	Decide whether you want to offset: a. A fixed amount of fuel and receive the certificate pre-charter b. The exact fuel consumption and receive certificate post-charter Either is possible. It is your choice.

Quotation	The quote will include a selection of the projects available to complete the carbon offset transaction.				
4. Include in Charter Agreement	Not Required	We recommend that a special condition* is inserted in to the charter agreement to give proper direction to the Captain / Manager.			
5. Finalise Order	Approve quote and confirm your selected project - If you have decided option b., you or the Captain confirm the exact fuel quantity at the end of the charter.				
6. Final Invoice	Yacht Carbon Offset will issue the final invoice, reflecting your selected project. You can settle the invoice by credit card or bank transfer.				
7. Certificate	You will receive your personalised Yacht Carbon Offset Certificate for presentation to the Charter Client.				

^{*}Suggested text for contract special condition:

a. Fixed Fuel Amount

Charter Carbon Offset – The Charter Client wishes to carbon offset [litres] of fuel in relation to the charter. The Parties agree that an [additional] APA provision of Euro [] shall be retained by the Broker for this purpose. The Broker shall arrange the carbon offset through its selected supplier. The Charter Client will receive the Carbon Offset Certificate [at the start of] the charter period.

b. Exact Fuel Amount

Charter Carbon Offset – The Charter Client wishes to carbon offset the fuel associated with the charter. The Parties agree that an [additional] APA provision of Euro [] shall be retained by the Broker for this purpose. The captain shall provide final fuel consumption information to the broker or nominated carbon offset supplier at the end of the charter. The Charter Client will receive the Carbon Offset Certificate promptly after the charter period.
