Our Pay-as-you-Go Service

Many Owners, Captains and Yacht Managers are keen to ensure that the carbon footprint of their yacht is counterbalanced. This is easy to do.....

Team up with Yacht Carbon Offset to establish a Carbon Offset Programme!

Our pay-as-you-go carbon offset service is applied each time you bunker fuel. It's easy to action and supports a reputable carbon reduction project of your choice around the world. All our projects are in **developing countries**, supporting the environment and giving back to local communities.

1. Our analysis shows that a yacht's fuel consumption is the largest greenhouse gas emission source of all the yacht's operating activities!

4. We issue a personalised certificate stating the tonnes of CO₂ offset, the fuel characteristics and the project selected to complete the transaction.



2. We calculate the greenhouse gas emissions associated with the quantity and quality of fuel each time the yacht bunkers.

3. We complete the offset by supporting a high-quality carbon reduction project. All projects are validated by one of four International Carbon Registries.



Carbon offsetting is a tool to counterbalance **unavoidable** greenhouse gas emissions. We actively promote its use in conjunction with other positive actions that help to reduce fossil fuel consumption, such as efficient yacht operation and management, engine technologies, and use of biofuel.

Our Pricing

At less than €0.05 per litre (at Q1, 2023), the price to offset is modest.

The annual cost of a carbon offset programme depends entirely on the yacht's operational characteristics and usage. Our carbon offset service is priced on a transparent price per litre basis. There are no other hidden costs or charges.

The Administration

Starting your Carbon Offset Programme

1. **Register Your Interest:** Send an email to sales@yachtcarbonoffset.com to request a no-obligation introductory call or meeting. Before working together it is important that you get to know the Yacht Carbon Offset team and learn why you can trust us to provide a quality carbon offset programme.

2. **Receive Access to your secure Yacht Carbon Offset Portal:** Used to request carbon offsets and store your Yacht Carbon Offset Certificates. To register we will need to receive the Yacht's Name, IMO & Flag, and the billing address.

3. **Start your Carbon Offset Programme**

Each Carbon Offset is a Simple 4 Step Process

1. **Request Offset:** The Captain or Yacht Manager uploads the yacht's fuel bunkering information to the Portal or sends an email to sales@yachtcarbonoffset.com. Information on other activities can also be included: shore power; fuel of private jets/helicopters; commercial flights of crew and guests.

2. **Receive Quote:** Yacht Carbon Offset will calculate the quantity of emissions associated with the fuel bunkering (and other activities if requested), and send a quote for completing the carbon offset. A list of the projects available to support will also be sent at this time.

3. **Final Invoice & Carbon Offset Completion:** On approval of the quote, Yacht Carbon Offset will issue an invoice and complete the carbon offset transaction by retiring the required number of carbon credits in the selected project from the relevant international carbon registry. The Captain/Yacht Manager can request to support a specific project or leave the project selection to Yacht Carbon Offset. 4. **Certification:** We issue a personalised Yacht Carbon Offset Certificate for each carbon offset transaction. Yachts following a regular carbon offset programme can also fly our Yacht Carbon Offset Flag.



Our Certificate

We certify each carbon offset transaction through the issuance of a personalised certificate.



Each certificate typically shows the Yacht’s name, the location, date and details of the emission activities, and the project selected to complete the carbon offset transaction. We adapt the certificate information to reflect your needs. We can keep disclosure to a minimum, if required.

The Certificate is uploaded to your secure & private Yacht Carbon Offset portal where you can view and manage all the yacht’s carbon offset activities.

Annual Carbon Offset Programme Activity Report

At the beginning of year we issue our Carbon Offset programme clients an activity report summarising the previous year’s programme activity. This is a useful record to demonstrate the fantastic environmental action undertaken by the yacht on a regular
